### Mayor Report Summary:

<u>Pennsylvania State Police (PSP) Report</u>: none received

• <u>District Court Reports</u>: A Notice of Judgment was received from Magisterial District Judge 19-3-04 on Wednesday, June 5 for Docket Number MJ-19304-CV-0000079-2024 (CV-79-2024) where the Individual Liability and Court Costs levied on the Defendant totaled \$514.72 for violations of Sections 402 (Unenclosed Storage) and 619 (Abandoned or Junk Motor Vehicles) of the Loganville Borough Zoning Ordinance. The additional \$500/day per diem fine was declined by the Borough.

- Emergency Management (EM):
  - <u>Fire Police Requests:</u> none received

• <u>Weather Emergencies:</u> Numerous National Weather Service (NWS) Central Pennsylvania Weather Briefs were received from the York County Office of Emergency Management (OEM) during June due to high temperatures. In addition, Web Emergency Operations Center (WebEOC) Incident Number 11017, Excessive Heat Warning, was issued county wide on Tuesday June 18 at 10:50 AM. OEM subsequently emailed their Extreme Temperature Plan with guidance for extreme temperatures. WebEOC Incident 11017 was closed on Thursday, June 27 at 7:55 AM.

# <u>Meetings/Training:</u>

I participated in Initial Damage Reporting training at OEM on Tuesday, June 4 from 10:30 AM -12:30 PM for initial local damage assessment. Training covered determining what happened and how it affects individuals and communities, how residential, business and infrastructure property is affected, which areas are hardest hit, which situations must be given response priority and what types of assistance are needed (e.g., local, state, or Federal). - <u>Meetings/Training (cont.)</u>:
  - The course covered basic municipality responsibilities for damage reporting to OEM post disaster. Instruction included collection and reporting of damages to dwellings and damages to infrastructure such as roads, bridges and culverts. The Impact Statement was also explained. Forms to collect damage information were also provided, as these will be helpful if Federal reimbursement becomes available to municipalities. A key take-way is to take annual photographs of municipal infrastructure (e.g., bridges, culverts, etc.), because before and after photographs must be submitted with claims for Federal disaster relief. Paradise Township was provided as an example for flooding they experienced a few years ago. The extent of damage to bridges and culverts was in the millions of dollars, far exceeding their annual road/infrastructure maintenance budget. Because Paradise had before and after photos, they were eventually totally reimbursed for the costs. Examples of cost reimbursements included but were not limited to labor (e.g., EMC and civil engineering damage assessment hours, cleanup and restoration labor hours, etc.), materials, equipment mobilization and operating hours and associated EMC and municipality administrative tasks.
  - Per York County OEM's June 10 email, quarterly EMC Training will be held at OEM, 120 Davies Drive, York on Thursday, July 18 from 6:30-8:30 PM. EMCs will tour and receive a presentation of the York County Mobile Command Unit and a training session on the new WebEOC Notification And Resource Manual (NARM) board. NARMs are separate documents that supplement Emergency Operations Plans. They provide emergency contact information, as well as a comprehensive list of emergency contact personnel, equipment, supplies and other resources that that can be mobilized in the event of an actual or potential disaster.
  - On Wednesday, June 19, the Borough Council (BC) President informed me that my presence will be required at Magistrate District Court 19-3-04 for a hearing on Monday, July 8 regarding Loganville Borough ordinance violations.

- <u>Miscellaneous:</u>
  - On Monday, June 3, the property cited in my June report was mowed, thereby negating the need for further action.
  - At 8:30 AM on Monday, June 24, the BC President and I visited a residential property that had sewer leaking issues that he'd been made aware of. We knocked on the door to notify the residents but there was no answer. Additional ordinance violations observed included: two (2) unregistered vehicles and two (2) structures and a swimming pool for which no permits had been issued. The BC President contacted the Sewage Enforcement Officer later that day to issue a citation for the leak.
  - The property which received the Notice of Judgment (Docket Number CV-79-2024) had the large vehicle towed away on Monday, June 24.
  - On Thursday, June 27, I was able to make contact with the manager of the commercial property which had noxious weeds that were identified at the June BC meeting. The property manger informed me that this would be resolved within the week.
