## Loganville Borough Mayor's Report – September 2024

**Issues/Concerns/Requests:** none

### Mayor Report Summary:

- Pennsylvania State Police (PSP) Report: none received
- District Court Reports: none received
- Emergency Management (EM):
  - Fire Police Requests: none received
  - Weather Emergencies: Numerous National Weather Service (NWS) Central Pennsylvania Weather Briefs were received from the York County Office of Emergency Management (OEM) during August due to heavy rains. In addition, York County OEM issued Web Emergency Operations Center (WebEOC) Incident 11371, Potential Flooding, countywide on Tuesday, August 6 at 2:41 PM. Loganville was not affected. WebEOC Incident 11396, Remnants of Tropical Storm (TS) Debby, was issued countywide on Wednesday, August 7 at 12:39 PM. TS Debby caused approximately 2,674 power outages as well as some evacuations in the western portions of York County. Incident 11396 was closed on Friday, August 9 at 3:26 PM.
- Meetings/Training:
  - On Tuesday, August 27, the Borough Council (BC) President and I visited the resident regarding Docket Number MJ-19304-CV-0000073-2024 (CV-73-2024) where the Civil Judgment, Attorney Fees and Court Costs levied totaled \$2,921.36 for violations of Loganville Borough Snow Emergency Ordinance 2010-01 and Amending Ordinance 2022-01. As the 30 day right to appeal CV-973-2024 had expired with no appeal filed, we informed the resident that the Borough had not received payment and it must be paid within five business days or a lien on the property would be levied for the amount due.

- Correspondence: none received
- Miscellaneous:
  - On the Wednesday, August 14 trash pickup, Republic Services (Loganville's waste removal provider) failed for a third time (the previous two failures were reported in July) to empty the same resident's trash container (non-Republic container). On this occasion, the resident contacted Republic directly with the Republic email addresses they obtained when they were copied for the previous two incidents. This was another violation of the current waste removal contract and the BC was notified. Republic's remedy was to issue a second, 96 gallon tote, as they introduced them mid-contract and their crews are told to empty them because they are Republic totes. This raises the question of why resident's own totes are not being emptied, for this appears to be a unilateral, arbitrary change to the existing contract terms by Republic.
  - After being contacted by a resident about a non-functioning street light on the west side of North Main Street (18 North Main Street, Pole No. 2927-19230), I submitted a report via the Met Ed/FirstEnergy web site [https://firstenergycorp.com/service\\_requests/report-lighting-problem.html](https://firstenergycorp.com/service_requests/report-lighting-problem.html) on Thursday, August 22 to report it. FirstEnergy Lighting Request W001762447725 was generated, but the light has yet to be repaired.
